# India reaches out to UNSC's non-permanent members

**PTI NEW DELHI**  
 India on Wednesday reached out to Denmark in line with its diplomatic overdrive to apprise the non-permanent members of the UN Security Council about the brutal Pahalgam terrorist attack with cross-border linkages.  
 On Tuesday, External Affairs Minister S Jaishankar spoke to his counterparts from seven non-permanent member nations of the UNSC.  
 Jaishankar held a phone conversation with his Danish counterpart Lars Lokke Rasmussen on Wednesday and is understood to have conveyed to him India's resolve to bring the perpetrators of the April 22 attack to justice. "Spoke with FM Lars Loeckke of Denmark.  
 Appreciate his support and solidarity over the terrorist attack in Pahalgam. Also exchanged views about our bilateral cooperation," he wrote on X.  
 Jaishankar's phone conversations with foreign ministers of the non-permanent member nations of the UNSC assumes significance as Pakistan is a member of the influential UN body for the 2025-26 period. He held conversations with his counterparts from Algeria, Greece, Guyana, Panama, Slovenia, Sierra Leone and Somalia on Tuesday. Citing "cross-border linkages" to the attack, India has promised punishment to those involved in the strike.  
**PAHALGAM ATTACK**  
**EAM SPEAKS WITH KUWAITI LEADER**  
 Jaishankar discussed the Pahalgam terror attack with his Kuwaiti counterpart, Abdullah Ali Al-Yahya. Jaishankar's phone conversation with Al-Yahya came amid speculation about India's possible response to the April 22 Pahalgam terror attack. "Glad to talk to FM Abdullah Ali Al-Yahya of Kuwait. Thanked him for Kuwait's solidarity and support in the aftermath of Pahalgam terrorist attack," the EAM said in a post on X.  
 US President Donald Trump, French President Emmanuel Macron, Israeli PM Benjamin Netanyahu, Egyptian President Abdel Fattah El-Sisi, Jordan's King Abdullah II and Italian PM Giorgia Meloni, also dialled Modi to condemn the strike.

# Angolan Prez on 4-day visit from today

**New Delhi:** Angola's President Joao Manuel Goncalves Lauro will pay a 4-day visit to India beginning Thursday to expand overall bilateral ties. It will be Lauro's first ever bilateral state visit to India.  
 The Angolan president is scheduled to hold separate talks with Prime Minister Narendra Modi and President Droupadi Murmu. The two sides are also expected to sign a number of agreements to shore up cooperation in several areas. "A visit of the president of Angola to India is taking place after 38 years. The visit comes at a time when India and Angola are celebrating the 40th anniversary of the establishment of diplomatic relations this year," the Ministry of External Affairs said.
